WHEREAS the Founders are desirous of setting up a Public Charitable Trust for the purpose of imparting education and training to young boys and girls as well as adults of all religion, caste and creed by setting up educational institutions with residential and non-residential facilities and also for the purpose of working for the upliftment of the public in general in social, cultural and educational fields.

AND WHEREAS the Founders have for the above formed a corpus with a total amount of Rs. 50,000/= [Rupees Fifty Thousand only] contributed by them and have set up a trust with the said amount as its Corpus Fund.

AND WHEREAS it is necessary to declare the objects and terms of the Public Charitable Trust so constituted under these presents:

NOW THEREFORE THIS DEED WITNESSETH AS FOLLOWS:

I: GENERAL:

1: NAME: The name of the Trust shall be "**GLOBAL EDUCATIONAL AND CHARITABLE TRUST**".

2: OFFICE: The Office of the Trust shall be VP 14/17A, Vengara Grama Panchayat, Kooriyad, Tirurangadi P.O., Malappuram District. However, it shall be open to the Trust to shift the office to any other place of convenience.

II: AREA OF OPERATION:

The area of operation shall be the entire State of Kerala. However, the Board of Trustees shall have the right to enlarge the area of operation.

III: AIMS AND OBJECTS OF THE TRUST:

1: Carry out all activities in relation to education within the area of operation specified supra and such wider area as may be decided by the Board from time to time.

2: Carry out charitable works for the betterment of all communities, in particular, for the educational, social and economic advancement of members of all communities and religion without reference to caste, creed or religion and for the said purpose, to set up educational institutions, academies, research institutions and the like.

3: To evaluate the abilities of students in the field of academic studies, sports, cultural events etc. and to take effective steps for imparting proper coaching in such fields.

4: To set up institutions and establishments teaching children at different levels and also for imparting literacy to the general mass and to eradicate illiteracy among the members of the down-trodden with special emphasis on training and developing creative instincts, power of concentration, retention capacity when the children are in their infancy itself, bestowing special attention in the case of slow learners after identifying them and subject them to scientific and technological tests so as to boost their self confidence and enabling them to keep abreast with their peers.

5: To set up institutions for training children in primary classes itself to enable them to follow Indian languages with special emphasis on ancient culture.

6: To set up institutions for implementing necessary programmes for upward mobility of students of upper primary classes by imparting communicative skills in them to be fluent in speaking flawless English language with the assistance of trained experts in the field to equip them to face challenges in later period in their academic curricular and job pursuits in the vast vistas of fast expanding computer technology

7: To set up institutions for enabling children in high school and secondary classes to face the examinations in a coolant ambience, to bolster up the human resources to circumvent the anxiety state of neurosis while facing examinations and more particularly entrance tests.

V: BOARD OF TRUSTEES:

1: The **FOUNDER TRUSTEES** shall form the **BOARD OF TRUSTEES** who shall be entitled to enlarge the Board by co-opting additional trustees for a more efficient working of the Trust. Such additional trustees shall be co-opted unanimously by the Founder Trustees as far as possible and in the event of any difference of opinion, by a Majority of the Founder Trustees.

2: The Board of Trustees shall have:

- 2: MANAGING TRUSTEE
- 3: SECRETARY
- 4: TREASURER
- 5: MEMBERS -

2: The BOARD OF TRUSTEES shall be a permanent body and the Addl. Trustees co-opted shall hold office for such period/periods as may be specified by the Founder Trustees at the time when they are co-opted.






4: The Members of the Board of Trustees – the Permanent Body – shall be entitled to nominate his successor and on resignation or death of any member of the Board of Trustees, such nominated person shall become the member in place of such member.

5: Any vacancy arising in the Office Bearers of the Board of Trustees by reason of death or resignation shall be filled up by the Board of Trustees from amongst the members and the person nominated in the place of the deceased or resigned member.

VI: BOARD OF TRUSTEES: POWERS AND DUTIES

1: The Board of Trustees shall be the authority to set up institutions, academies, colleges, schools etc though the running of such individual establishments shall be carried out through Managing committees set up for each of such institutions. Such institutions shall be set up by using the corpus of the Trust and by collecting donations from the Public and other Charitable Institutions, Trusts, etc. having identical objects and to run the same.

2: To supervise and control the running of such institutions in order to ensure that such institutions run in accordance with the aims and objects of the Trust.

3: Lay down the ground rules for running of such institutions.

4: Set up Managing Committee/s for running individual institutions as set up above and shall conduct elections, wherever found necessary, to such Managing Committees in accordance with the Rules and Regulations framed by such Managing Committees and in accordance with statutory requirements.

5: Take policy decisions on the setting up of and running of various institutions, academics, colleges, schools, etc.



VIII: OFFICE BEARERS: RIGHTS AND DUTIES:

1: CHAIRMAN:

The Chairman shall preside over the meeting of the Board of Trustees and control such meetings.

2: MANAGING TRUSTEE:

2.1: The Managing Trustee shall be responsible for the running of the various projects of the Trust and be responsible for the day-to-day running of the Trust and its Projects.


2.2: The running of the various individual institutions of the Trust shall be in coordination with the various Managing Committees floated for each such Project.

2.3: The Managing Trustee shall be the appointing authority for all appointments made by the Trust and shall be in charge of the Accounts and shall be the authority to acknowledge receipt of all amounts by the Trust either by way of donation or by way of addition to the Corpus of the Trust and be in charge of all institutions run by the Trust. He shall also be the disciplinary authority in respect of all employees.


2.4: The Managing Trustee shall operate all bank accounts of the Trust along with Treasurer and/or General Secretary.


2.5: The Managing Trustee shall call for the meeting of Board of Trustees and Issues notices and fix the agenda of each meeting.







2.7: Shall operate bank accounts as authorized by the Board of Trustees in accordance with the resolutions adopted from time to time.

2.8: The Managing Trustee shall have the right to nominate, as the representatives of the Board of Trustees, members to the Managing Committee/s of the various Institutions set up by the Trust, from amongst the members of the Board of Trustees and to nominate specific members, out of such nominated members, as Directors of the said Managing Committee/s..

3: SECRETARY:

The Secretary shall be the correspondent of the Trust and shall carry out duties as are assigned to him by the Board of Trustees.

4: TREASURER:

4.1: The Treasurer shall be the custodian of all accounts and shall be responsible for effecting payments against the authorizations granted by the Managing Trustee, in accordance with the resolutions adopted buy the Board of Trustees from time to time.

4.2: The Treasurer shall ensure proper maintenance of the accounts of the Trust and shall get the accounts audited in time every year and shall ensure preparation of all statements to be filed before statutory and/or quasi governmental authorities from time. He shall also operate the Bank Accounts in accordance with the resolutions adopted by the Board of Trustees from time to time.

4.3: Unless otherwise decided by the Board of Trustees, the Treasurer shall ensure that all payments in excess of Rs10,000/= shall be incurred only through account payee cheques and all individual payments less than Rs. 10,000/= may be incurred in cash, at the discretion of the Managing Trustee.

IX: MEETINGS OF THE BOARD OF TRUSTEES:

9.1: The Board of Trustees shall meet at least once every six months. However, the Managing Trustee shall be entitled to call for meetings as and when found necessary.

9.2: Notices for regular meetings of the Board of Trustees shall be sent at least seven days in advance while in the case of emergent meetings, there shall be a notice of three days. However, in the case of emergent meetings, the Managing Trustee shall have the right to reduce the notice period.

9.3: Each meeting of the Board of Trustees shall have a quorum of 2/3 of the total number of the members. Any meeting adjourned for want of quorum may be held on another date at the convenience of the members present and such meeting need not carry quorum.

9.4: Decisions of the Board of Trustees shall, as far as possible, be unanimous. However, in the event of a vote being found necessary, such decisions shall carry the support of 2/3 of the total numbers present and voting at such meeting/s.

9.5: It shall be open to the Board of Trustees to approve of resolutions by circulation with the permission of the Managing Trustee.

X: OTHER MATTERS:

10.1: At the end of every financial year, the Books of Accounts shall be finalized and the same shall be got audited by an Auditor appointed by the Board of Trustees. The General Secretary shall submit such audited accounts every year before the Board.

10.2: All amounts received by the Trust as part of the Corpus and/or donations shall be used in accordance with the objects of the Trust.

10.3: The entire income of the Trust shall be used in accordance with the objects and aims of the trust and in accordance with the terms of the Incometax Act in existence.

10.4: The Board of Trustees shall be entitled to formulate such Rules and Bye-laws and procedures as are found necessary for the proper running of the Trust and its institutions.

10.5: All fixed assets including properties now available and those to be acquired in future shall belong to the Trust alone and shall stand in the official names of the Chairman and/or the Managing Trustee.

10.6: The Managing Trustee and the Treasurer shall prepare every year, a budget for the operations of the Trust for one year and place the same before the Board of Trustees who shall accord approval for the same, subject to any changes that the Board may deem fit to carry out. The activities of the Trust shall be run in accordance with the Budget and any changes in the same shall be carried out only with the approval of the Board of Trustees.

XI: TRUST IRREVOCABLE:

The Trust - GLOBAL EDUCATIONAL AND CHARITABLE TRUST - shall be an IRREVOCABLE TRUST. The present Trustees or their successors shall not be entitled to invalidate the Trust. The Corpus of the Trust as well as future accretions shall belong to the Trust alone. It shall, however, be open to the Board of Trustees, subject to concurrence of 75% of the total members of the Board, to amalgamate the Trust with any other Trust with identical objects.

XII: CORPUS OF THE TRUST AND APPLICATION OF NET INCOME OF THE TRUST:

12.1: The Corpus of the fund shall be Rs. 50,000/= which has been contributed by the Founder Trustees. Any additions to the Corpus received from well-wishers and donors shall be used by the Trust in accordance with the objects and aims.

12.2: The net income of the Trust shall be utilized, in accordance with the objects and aims of this Trust as stipulated above and shall also be applied, in accordance with the provisions of Indian Incometax Act and no part of the same shall be used for the personal benefits of either the Founder Trustees or the members of the Board of Trustees.

XIII: AMENDMENTS TO THE TRUST DEED:

13.1: The Board of Trustees shall be entitled to carry out any amendments to the provisions of this Deed of Trust which are found necessary for achieving the objects of the Trust. However, any such amendments shall be carried out only after the prior approval of the Commissioner of Incometax having jurisdiction over the area where the Trust has its office.
